Greetings, Shipmates,

We had a fantastic city tour on the enclosed trolley on Thursday with Arthur, our guide and driver, who shared the history of nearly every building at each turn and block in Mobile's historic downtown before dropping us off at the USS Alabama Memorial Park to explore the ship and many displays. Later in the day, our fifteen-passenger van proved invaluable as we headed out for an evening of Italian dining together.

Wow, everyone had positive feedback on the highly informative and fascinating, never-to-forget Airbus Assembly Plant Facility tour we took on Friday morning. We learned a great deal, including the multiple countries of origin for many of the aircraft's components and modules.
