Despite the lower-than-expected turnout, we continued with the planned agenda. Ellis was able to adapt to the situation by canceling our bus transportation commitment without penalty and securing two 15-passenger vans in its place. Our use of the vans not only served a practical purpose but also fostered a sense of camaraderie as we traveled together to and from our group activities and to local eateries for dinner. Reunion Background and Planning:
With the reduced attendance we see With the reduced attendance we experienced at the most recent reunion in JAX, future reunions must be affordable and financially self-supporting. This deficit is **not** due to poor financial planning, as historical attendance, revenue, and expense records guide estimates and projections for the next reunion. As one would expect, the planning process starts months, usually more than a year in advance of the actual date of the reunion. Financially, our organization operates solely through donations from our members. Donations to the General Account are not intended to support the reunions; reunions should be financially self-supporting.

So, where did we fall short, and how should we proceed as we consider the next reunion? This is where each of you who were not in attendance must assist us. Recalling The Field of Dreams phrase, "If you build it, they will come." Your Board of Directors is committed to maintaining our annual reunions; your attendance is essential for us to continue to offer them. So, how should we "build it?"
